Hello to all RCR-Newton Property Owners:

The annual meeting of the RCR-Newton Property Owners Association, Inc. membership will be held at 10:00 AM on Saturday, September 23, 2017, at the **Rawlings Public Library in the Ryal's Meeting Room**, located **at 100 East Abriendo Avenue**, **Pueblo**, **CO 81004-4290**. This meeting room is the same as in year's past and is located on the fourth floor of the library.

Road conditions on the ranch remained somewhat rough throughout most of the winter, but manageable with some spot maintenance of washboarded areas. Because of this, we were able to defer a regular road grading/maintenance cycle last fall to leverage approximately \$20,000 in additional funds for road base and a complete grading, watering and rolling in May of this year. So far, the new road base and grading is holding up well through some major rainfalls. Road conditions and needs are continually addressed as a standing agenda item at each board meeting.

The 2018 annual assessment will be \$300 per lot (\$150.00 regular assessment and \$150.00 special assessment) as is set forth in the Covenants. As you all may know from last year, the Association is <u>not</u> under the Colorado Common Interest Ownership Act (except for a few sections) and therefore, our assessments are limited by the original covenants and cannot be increased even for cost of living because of the date that they were created in 1996.

At the annual meeting this year, 3 directors will be elected. The terms will start on January 1, 2018 but any new directors are encouraged to start attending Board meetings for the remainder of this year. We encourage you to get involved if you haven't in the past. This is your community and we need board members to help it succeed. If you have been a Board member in the past, please consider running again.

Enclosed please find a copy of the 2018 proposed budget, as well as a voting proxy. If you are unable to attend the annual meeting but would like to have another member vote on your behalf, please fill out the proxy. Proxies may be delivered to the Secretary, George Johnson, any time prior to the meeting, including the day of the meeting. Please designate on the proxy what your designee can vote for.

Again this year, the Board requests that all meeting attendees be thoughtful and courteous to their neighbors. Recent meetings have gone very well and have been concise and informative. All members in good standing will be allowed to voice opinions and concerns.
