Paragraph 14: DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of RCR-Newton Property Owners Association, the Association will, pursuant to C.R.S. § 7-134-105(1)(c) of the Colorado Revised Nonprofit Corporation Act, transfer or convey its assets to a successor association organized for the same purposes as this Association as set forth in Paragraph 15(A) and (B) of these Articles, unless the common interest community is terminated pursuant to § 10.2 of the Declaration of Covenants, Conditions, Restrictions and Easements for Red Creek Ranch dated May 23, 1994. In the event the common interest community is terminated, its assets will be distributed in the manner provided in § 38-33.3-218 of the Colorado Common Interest Ownership Act.

Paragraph 15: ADDITIONAL INFORMATION WHICH MAY BE ATTACHED:

The purposes and powers of the RCR-Newton Property Owners Association are:

- (A) To provide a means of self-government for the owners of property within a common interest community known as the RCR-Newton Property.
- (B) To perform all duties and exercise all powers and rights of the Association set forth in the Declaration of Covenants, Conditions, Restrictions and Easements for Red Creek Ranch dated May 23, 1994, recorded in Book 2735 at Pages 183-190 of the records of the Pueblo County Clerk and Recorder, in Colorado ("the Declaration"), and all amendments thereto; the Colorado Revised Nonprofit Corporation Act; the Colorado Common Interest Act; or other applicable law consistent with its nonprofit purposes.
